You are encouraged to check with your current cellular carrier and obtain your messaging options and costs prior to registering for this service. Most local carriers do not charge for incoming messages and standard rates are normally .05 / .10 per message.

A test message will be sent several times each semester to your mobile phone to insure the system is functioning properly. It will read: TEST-BCCC TEXT ALERT SYSTEM – END OF TEST.

Messages will come to your message inbox on your cell phone. Depending on the brand and features of your phone, this alert will come in only as a single message but some carriers might send it as 2 or 3 messages.

PLEASE READ ALL MESSAGES SENT!

The other messages might include a legal disclaimer that have to be on all emails generated by the BCCC campus email (Groupwise) system.

NOTE – THIS REGISTRATION EXPIRES 2 YEARS FROM THE DATE LISTED BELOW.
